Operator Management

➔ Bug fixing

- ➔ A BCP officer can add a non-LMS section (example RFL) to an LMS operator.


It was not possible to a Border Control Post (BCP) officer to add a Responsible for the Load (RFL) activity section to an existing operator when this operator was an approved operator in the EU, e.g. activity EURPO under the Plant Health section or any approved activity under the FOOD or Animal By-Products sections.

Now a BCP officer can add and validate the activity RFL to any existing Approved (LMS) operator in the EU.

➔ Improvements

- ➔ New operator Section "Veterinary Practices or Clinics" has been created

This new section has been created under the Animal Chapter to register veterinary clinics and practices in TRACES. Member States authorities will find this new section in the list of veterinary sections. An update on how this section will be used in relation to the control rules in the INTRA module will soon be provided to Member States TRACES contact points:



As of Release 6.13.0, the approval number/identifier will be mandatory for all sections within the chapters "Germinal Products" and "Animal" (except for "OTH-OPER" activity for the latter).

Specifically, when creating an operator under these chapters, the identifier field will be highlighted with a red asterisk:



I. Scenario for EU/EFTA countries

EU/EFTA countries competent authorities can create operators with sections under the chapters "Germinal Products" and "Animal" directly from the "Actors" > "Operators" section.

After completing the mandatory fields, it is possible to click "+ Add Activity Section". By selecting the desired section (e.g., DCF-EST Dogs, Cats, and Ferrets activity), the identifier field (excluding for the generic activity OTH-OPER) will appear as mandatory, marked with a red asterisk:



If the identifier field is not completed, the system will display an error message (Error: Identifier Must not be empty):




Once the identifier is filled in, the operator creation process can be finalized by clicking the "Create" button.

II. Scenario for non-EU countries

The creation/modification of operators under the chapters "Germinal Products" and "Animal" (excluding the generic EXP –Animal exporter) originating from non-EU countries must be managed through the creation of establishment listings via the dedicated listing module: [LMS listing](#)

➔ Additional filters added to the advanced search option for operators

Similar to the function 'Find my operators as' available for Organic Control Body users via the operator Advanced search page, Member State Authority users will have now the possibility to search using additional filters:

The importation tool lacked the possibility to specify an activity type for operators mentioned in the Commodity Description section of the document, i.e. Slaughterhouse, Manufacturing plant, Cold storage, Cutting plant. Whenever an operator with multiple activities was set to be imported into a line, TRACES chose one of these randomly to fill it in.

Previously, importing this operator with the intent of choosing Slaughterhouse would have TRACES choose randomly among available activities. The user must then check and correct each operator among the sometimes tens of lines of Commodity descriptions.

Change of the timing TRACES Notifications are sent out to the users

The current timing of notifications that are being sent out to TRACES users was based on fixed timeslots, which were predefined, and users had the possibility to select a different slot. However, not many users selected a different timing – so the predefined timeslot was too congested and not all foreseen notifications could be delivered.


To better distribute the notifications across the whole day, from version 6.13.0 onwards each user is assigned to a random hour in the following intervals: 02:00-06:00, 07:00-18:00, 19:00-23:00 CET during which they will receive the system notifications.

- ➔ INTRA for Export box I.22 'For transit through Member State(s)' becomes mandatory:

When creating an EU INTRA certificate for a consignment intended for export from the EU, **box I.22 For transit through Member State(s)** becomes mandatory and is pre-filled with the country of the BCP (without the possibility to clear it) if the "Exit BCP" (box I.23) is not in the same country as the "Place of dispatch" (box I.11). It is still possible to add other transit Member States.

When issuing a "Replacement" of an EU INTRA which is linked to an AJL, the system will retain the linked AJL and the link will not be removed. The system allows the selection of a different AJL if needed.





When a DOCOM is created in a single step, without going through stages like "draft" or "new," the "Last update on" field reflects the date of its signature or creation. This ensures the document is included in the search index for retrieval.



The TRACES interface was lacking the possibility to add more than a single either Storage life value or Date of Freezing value. It is now fixed, and one can include additional values by clicking on the plus sign at the right side of the field.

- ➔ **CHED-PP for Wood Packaging Material (WPM): creation by cloning of the CHED-A/P/D**

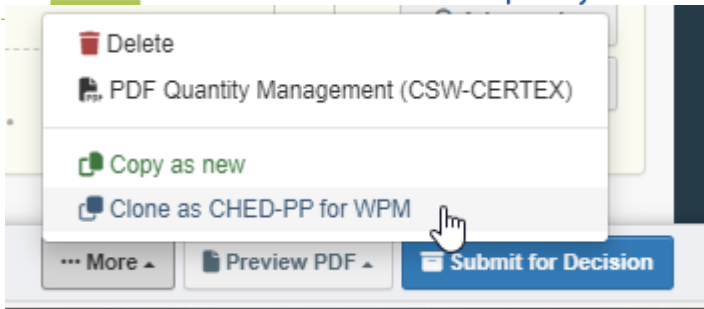
A new functionality has been developed in order to facilitate the creation of a CHED-PP for WPM for consignments of animals, products of animal origin and food and feed of non-animal origin which are being transported in wood packaging material which is subject to official controls.

The newly established cloning functionality not only facilitates the creation of the relevant CHED-PP document but will also form a link between the two CHEDs and ensure that the relevant information such as the type, quantity and weight of the goods is accurate across the two entry documents.

This improvement aims to address issues that were reported in the context of automated customs clearance of such consignments by the EU CSW CERTEX in cases of mismatches or missing information.

This additional CHED-PP can be created directly via a new command button "Clone as CHED-PP for WPM"

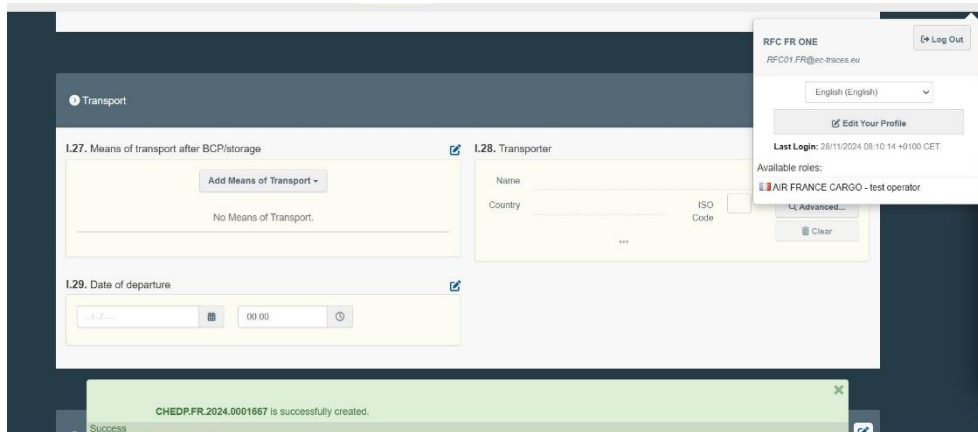

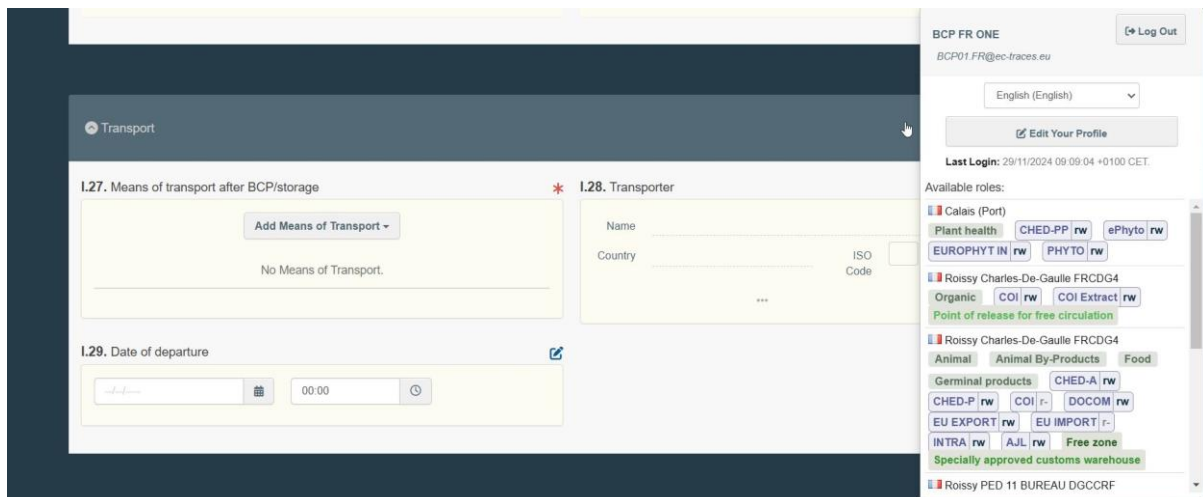

As a Responsible for the Load, the completion of box I.27 is now not mandatory when submitting a CHED f for Transit, Transshipment and Onward travel.



As BCP user, box I.27 becomes mandatory before validating the CHED.








