

General Improvements - Bug fix for the management of authorities: Country Administrator users can edit certain authority details

After the discovery that Country Administrator users where able to edit authorities in their countries without any restrictions, the possibility to edit the authorities was removed from them completely some time ago.

The settings have been fixed and Country Administrator users are now able to

- Edit the authorities' contact details: adding or editing an email address, phone number etc. But NOT changing the authority's name or address.
- Additionally, they are able to modify the regions assigned to the authority's activities.

Both boxes have an "edit" button that the user needs to click in order to update the information:

General Improvements - Means of Transport management: LMS NCP users are able to create and activate livestock vessels

An LMS NCP user can create and validate Livestock vessels in their country through the main "Means of transport" menu. To do that, the user needs to click on "New Means of Transport" and select "New ship":

On the ship's certificate page enter all mandatory information, click on "create certificate" and then on the little back arrow to return to the main page of the vessel. The certificate is automatically added to the details and you will now be able to activate the vessel as described above.

General Improvement – Operators' management: activity type code displayed next to the activity

Since ABP operator activity type official names are very long and not very user-friendly, their official codes are now displayed next to the spelled out activity.

Example:

OCAFTB - "Alternative processing method: combustion of animal fat in a thermal boiler process plant"

The change has been applied to all chapters where activities do have an official code (e.g. Food).



Establishment amendments lists - ABP – Improvement: operator inside the EU – adding a category is now mandatory

When creating an ABP operator in an EU Member State it is now mandatory to indicate the category (i.e. Category 1, Category 2 and Category 3). It is not possible to successfully create an operator under the ABP chapter without the indication of the category. The system will display an error message.

Visually, the category is shown in red until the selection is made. The box is also marked with an asterisk:

Establishment amendments lists – Bug fix: Synchronization issues have been resolved

An issue concerning some synchronisation problems that resulted in discrepancies between the PDFs and the operators that are found in the main menu has been fixed.

IMPORT - Improvement: New values added for Box I.20 "Certified As or For"

In order to follow COMMISSION IMPLEMENTING REGULATION (EU) 2020/2235, new values for the Box I.20 "Certified as" of the EU Import have been added in TRACES NT:

- Further keeping
- Organic fertilizers and soil improvers
- Exhibition
- Ornamental aquaculture establishment
- Release into the wild
- Confined establishment



DOCOM - Bug fix: Replacement DOCOM PDF was missing reference to the Replaced DOCOM

The PDF of a Replacing DOCOM did not have the reference to the Replaced DOCOM (and vice versa). The bug is fixed and the document are now refferenced.

DOCOM - Improvement: A DOCPOM can now be saved as new

A user can now save a DOCOM in status NEW. This DOCOM gets a final reference number, is visible to all concerned users but can still be updated before it is signed.

A DOCOM can be saved as "NEW", when it is started and is currently UNSAVED or when it is in status DRAFT. in both cases a "Save as New" button is available to the user.

Note that the following actions are available once a DOCOM in status NEW:

- Save as New
- Sign
- Cancel
- Replace
- Copy-as-New

INTRA – Improvement for the submission of controls

It is now possible to submit a control with the option 'no' selected in box III.2, III.3 and/or III.7.

INTRA - Introduction of the digital signature

The digital signature for EU INTRA, is now available for the certifying official veterinarian and AVO users.

Veterinary authorities that are already signing electronically CHED-A/-P, will be able to apply the same e-seal so as to sign electronically official certificates for Intra Union movements. Authorities that are not yet equipped with an electronic seal, are kindly requested to contact the TRACES Helpdesk to express their interest.



Admin users of authorities that are already equipped, can delegate the use of the organisation's eseal to other users, or users from subordinate authorities. In case of further questions on the use and delegation of the electronic seal in TRACES, please contact the TRACES Helpdesk.

Please note that the use of the electronic seal for the EU Intra module will also be enabled for users of Appointed Veterinary Offices. For the use of the e-seal by AVO users, the same rules as regards the seal delegation apply just like for authority users.

CHED-PP: Special import requirements, a new help-to-decision tab in CHED-PP

This new tab will allow operators responsible for the consignment and EU border authorities to check if all import special requirements have been included in the additional declaration of the phytosanitary certificate.

IMPORTANT: The completion of the new Special Requirements' tab is optional.

The relevant special requirements articles will be displayed depending on the selected EPPO code, CN code, country of origin, region of origin, country of destination or region of destination and a series of questions that will have to be answered by the user.

IMPORTANT: Please keep in mind that this help-to-decision tool is still under development and is still at its initial stage. Therefore, not all regulations/decisions/emergency measures are included yet. If you detect an article missing, please report it to the TRACES Helpdesk. Work is already in progress to make this tool more user-friendly (less questions, more automation, etc.).

IMPORTANT: Please also note that the scope of this tool is to <u>assist</u> official inspectors but will not replace the inspectors' tasks with regards to taking the final decision on the consignment that is presented for official controls. TRACES is not to be blamed for a wrong decision made in case of any missing information.

CHED-PP/PHYTO: Migration of EU plant health operators under the "PLANTS" section

EU operators in section PLANTS will be migrated into the EUPO* or EURPO** sections with version 6.4.0.

EU PLANT operators in status "New" will be migrated to the EUPO section keeping their status "New".

EU PLANT operator in status "Valid" will be migrated to the EURPO section keeping their status "Valid".

*EUPO: EU professional operators other than EU registered professional operators

**EURPO: EU registered professional operators



CHED-PP: Improvements on the non-compliance tab

Small bugs affecting the *details on the non-compliance* tab have been fixed. Notably, the tab now remains visible when the CHED-PP status is "replaced". This will allow better traceability of the decisions that have been taken on the consignment (e.g. a CHED-PP that was rejected because of a documentary issue can be replaced by a valid CHED-PP if the documentary issue has been corrected). The documentary issue can be traced back from the initial CHED-PP.

Additionally, a delete button has been added, which will allow the inspectors to delete the tab when necessary. E.g., in case the problem was quickly solved or in case of a mistake by the inspector.

COI – Updates of box 6 "Operator who buys or sells the product without storing or physically handling the product"

- Modification of box 6 "Operator who buys or sells the product without storing or physically handling the product" so the component is already displayed when the COI is initiated and there is no need to click on "Add":

Organic Operator Certificate – New functionality to delete a certificate

New functionality that enables users to delete an organic operator certificate. A certificate can be deleted:

- in DRAFT status
- By the user who created the Certificate

It would be also important: not to forget to delete any existing link. E.g. if the draft is reissuing a certificate, when it is deleted, the link will be deleted as well, so that the 1st certificate can be reissued again.

Concerning the operator activities, they are not created/modified when a certificate is still in draft status, so deleting the certificate should not have any effect on them.

Organic Operator Certificate – further improvements

Further improvements have been implemented concerning the validity of the organic operator certificates:

- when a certificate is about to expire, the control body of the operator will receive a notification
- The validity of an organic operator certificate is automatically set to "expired" when the expiry date is reached
- A certificate that is in status "suspended" is automatically set to "expired", if the expiry date is reached, when the certificate is reinstated.
